In continuation to the Government Order No : 146-JK(SWD) of 2021 Dated : 21-10-2021 , and as per recommendation of the J&K Services Selection Board, sanction is hereby accorded to the appointment of 15 selected candidates against the post of Class-IV in the Divisional/ various District Cadres of Jammu/Kashmir as per the details forming annexure to this order in the Pay Level of SL1 (14800-47100) in the Mission Directorate ICDS,J&K.

The appointee(s) shall report to Mission Director, ICDS, J&K, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

The appointment of the appointee(s) shall further be subject to the following conditions:

1. Academic Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate.
5. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The appointment of the appointee(s) shall further be subject to the following conditions:

- i. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- ii. That the appointee(s) shall furnish an undertaking in the enclosed format that no criminal records and also not facing any criminal proceeding in any Court of Law

- iii. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of qualification/other certificates are received from the concerned authority.
- iv. All these appointments are in terms of the Jammu and Kashmir Probationer (Condition of Service, pay and Allowances) and Fixation of Tenure Rule, 2020 notified vide S.O. 192 of 2020 dated 17.6.2020.
- v. The cadres/Departments allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department.
- vi. The appointments shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- vii. If the candidates fails to join within a period of twenty one (21) days from the date of issuance of order they shall forgo right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- viii. All the appointment orders shall be issued subject to outcome of any petition/(s) pending in any competent Court/Tribunal etc.



