Whereas, vide this office advertisement notice no. 01 SC (MV) of 2022 dated 01-08-2022 and 02 SC (MV) of 2022 dated 01-08-2022, applications were invited from the eligible applicants for the positions of Members of Juvenile Justice Board and Chairpersons / Members of Child Welfare Committees respectively;

Whereas, in response to the above advertisement notices, the applications received against the advertised positions were scrutinized and list of eligible and non-eligible candidates were prepared on the basis of the documents submitted by the candidates;

Whereas, the eligible candidates having applied for the positions of Chairperson/Members of Child Welfare Committees and Members of Juvenile Justice Boards for Kashmir province were called for interaction vide Notice issued under endorsement No. MS/SC/2022/04-09 dated 06-12-2022 by the Selection Committee constituted by the Government vide Notification dated 8th July, 2022 under The Jammu and Kashmir Juvenile Justice (Care & Protection of Children) Rules, 2021;

Whereas, after publication of the aforesaid notice, three candidates as reflected below at S.No. Supp-01, Supp-02 & Supp-03 represented before the Selection Committee that they have not been called for interaction despite being eligible and fulfilling the requisite criteria laid down for such post(s);

Whereas, one candidate as reflected at S.No. Supp-04 below had been skipped due to oversight during the screening of the application forms and as such was not called for interaction;

Whereas, the Committee examined the representations of the below mentioned first three candidates and found their claims as justified and accordingly decided to conduct their interview besides the interview of the candidate who had been skipped due to oversight;

Now, therefore, in continuation to the earlier interaction Notice issued by this office under endorsement No. MS/SC/2022/04-09 dated 06-12-2022, the interaction/interview date for the below mentioned four candidates has been fixed on 23-01-2023 by the Selection Committee. As such, all the
