NOTIFICATION

Jammu, the 6th January, 2022

S.O. // – In exercise of the powers conferred by section 23 of the Jammu and Kashmir Reservation Act, 2004, the Government of Jammu and Kashmir hereby makes the following amendment in the Jammu and Kashmir Reservation Rules, 2005; namely:-

‘In rule 24, for the words and sign “the certificates shall be renewable after following the procedure prescribed for issuance of such certificates.”, the words and sign “in the case of Economically Weaker Sections (EWS) for a period of one year from the date of its issuance. The certificates so issued shall be renewable after following the procedure prescribed for issuance of such certificate,” shall be substituted.’

This notification shall be deemed to have come into force w.e.f 1st of November, 2019 i.e. the date notification SRO 518 of 2019 dated 02.09.2019 has come into force.
