S.O. 252.-Whereas, Mission Director, Mission Vatsalya (Ex-officio Member Secretary, Selection Committee) vide letter No. MS/SC/76/2022/1967 dated 08.12.2023 communicated to the Department the panel recommended by the Selection Committee constituted vide Notification S.O. 331 dated 8th July, 2022 for filling up of 01 post of Chairperson and 23 posts of Members, CWC across 10 Districts of the UT including two Members of CWC, Kulgam;

Whereas, in accordance with the recommendations of the Selection Committee and subsequent vetting by the Department of Law, Justice & Parliamentary Affairs, the Department notified the appointment for 01 post of Chairperson and 23 Members, CWC across 10 Districts **as per S.O. 88 dated 07.02.2024** including the appointment of the following two members for District Kulgam:-

1. Ms. Neelofar Jabbar D/o Mohd Jabbar Bhat R/o Katapora Yaripora, Kulgam.
2. Mr. Farooq Ahmad Dar S/o Ab. Ahad Dar R/o Narkora Budgam.

Whereas, Mission Director, Mission Vatsalya, vide letter No. MS/SC/76/2022/180 dated 09.02.2024, communicated that out of the two positions for Member, CWC Kulgam, as appointed vide Notification S.O. 88 dated 07.02.2024, one position had already been filled by the appointment of Ms. Shugufta Parveen, D/o Gulam Nabi, R/o Qaimoh Kulgam, as per Notification S.O. 605 dated 06.12.2023, thereby leaving behind only one vacancy for the position of Member, CWC, Kulgam and recommended withdrawal of appointment of one of the selected candidates based on their order of merit;

Whereas, the merit position of the two members, CWC Kulgam is as follows:-

1. Ms. Neelofar Jabbar, D/o Mohd Jabbar Bhat, R/o Katapora Yaripora, Kulgam has been awarded **76.8 points** by the Selection Committee.
2. Mr. Farooq Ahmad Dar, S/o Ab. Ahad Dar, R/o Narkora Budgam has been awarded **73.2 points** by the Selection Committee.

Now, therefore, as per the report of Mission Director, Mission Vatsalya, Ex officio Member Secretary Selection Committee and the merit/vacancy position in place, it is hereby ordered that the appointment of Mr. Farooq Ahmad Dar S/o Ab Ahad Dar R/O Narkora, Budgam vide Notification S.O 88 dated 07.02.2024 is hereby withdrawn ab-initio and accordingly entry at S.No. 02 under District Kulgam in Annexure 'A' to notification S.O 88 dated 07.02.2024 shall and shall always be deemed to have been deleted.
