Whereas, applications on the prescribed format has been invited from the eligible and interested social workers for appointment as chairperson/member child welfare committee and member Juvenile Justice Boards in each district of UT of J&K vide Advertisement Notice No. 01 SC(MV) of 2022, dated 01-08-2022 & Notice No. 02 SC(MV) of 2022, dated 01-08-2022;

Whereas, applications were received and has been scrutinised in the Directorate in pursuance of Section 4 & 27 of Juvenile Justice (Care & protection) Act 2015 read J&K Juvenile Justice (Care & protection) Rules 2021 and accordingly list of all the eligible and In-eligible applicants/candidates has been published in two local newspapers and also in the website of the Social Welfare department, for inviting objections, if any;

Whereas, several representations has been received and has been examined and considered by the department whichever found genuine;

Whereas in the meanwhile the Hon'ble High court at Srinagar in the case titled Court on its own Motion V/s State of J&K & Ors. PIL No 09/2013 & 09/2015, vide order dated 30-11-2022 *directed that the applicants shall be allowed to submit their applications within three days from today before Member Secretary Selection Committee, Mission Director Vatsalya, J&K and on receipt of the applications, the applicants shall be allowed to compete the process of selection, if otherwise eligible*;

Whereas accordingly the application forms has been received from the eligible applicants for three days in pursuance of the Hon'ble High court order dated 30-11-2022;


Whereas interaction/interview dates for Kashmir province has already been notified and conducted vide notice No. MS/SC/2022/04-09, dated 06-12-2022;

Now, the interaction/interview dates for Jammu province has been fixed by the committee and has been **annexed** with this notice for the information of all the eligible candidates.

The candidates are advised to report for personal interaction/interview in the office of Selection Committee at Green belt Park, Gandhi Nagar Jammu -180004, as per date and time shown against each:-

#Note

- a. The eligibility of the candidates is subject to the provisions contained in Juvenile Justice (Care & protection) Act 2015 read J&K Juvenile Justice (Care & protection) Rules 2021.
- b. The selection committee will evaluate the candidates on the basis of the qualifications, experience of working with children and personal interaction/interview with the candidate. The allocation of points/marks, out of 100 marks will be as under:
 - i) For qualification 35 Marks i.e 25 for basic required qualification, 3 marks for PG/LLM, 2 marks for M. Phil, 4 marks for Phd/LLD and 1 marks for post doctorate provided the qualifications are in a relevant discipline from the recognised universities.
 - ii) For experience 35 marks i.e. 25 for basic required experience, 1 marks for each additional year of experience subject to the maximum 10 marks.
 - iii) For personal interaction/interview by the selection committee 30 marks to be awarded by the selection committee.
- c. The candidates shall produce all the original certificates/testimonials/marks sheets on the date of interaction.
- d. The permission to appear in the interaction is purely provisional and subject to fulfilment of eligibility conditions under rules.
- e. The interaction/interview dates are subject to change in case of exigency.
